## **CALL TO ORDER**

#### **ACTION ITEMS**

Rector Haymore acknowledged the agenda for the meeting includes nominations for Rector for fiscal year 2025, nominations for Vice Rector and fiscal year 2025, and the nominations for secretary for fiscal year 25. Per the bylaws of the nominating committee shall make its recommendation for the Rector at the first regular board meeting of the calendar year, which is this meeting.
