Proposed revisions to Academic and Health Affairs Committee Charter and Meeting Planner

Background: As a public institution in the Commonwealth of Virginia, many actions affecting academic programs and the academic organizational structure require State Council of Higher Education for Virginia (SCHEV) approval. SCHEV requires Board of Visitors approval for only a small number of these actions. However, VCU has developed over the years multiple internal approval steps, including BOV approval, which SCHEV does not require for most SCHEV actions. These added steps have led to VCU being out of compliance with some of SCHEV's submission deadlines, requiring additional revisions by faculty and delays to implementation which can impact student success and revenue generation.

Proposed revision: Remove the requirement for the Board of Visitors, by recommendation of the Academic and Health Affairs Committee, to approve SCHEV proposals for which the state does not require BOV approval. Only items for which SCHEV requires institutional BOV approval, and items that university leadership deems necessary for BOV review, will be brought to the AHAC. The Office of the Provost will provide AHAC/BOV with a list of all other SCHEV actions as an information item at its meetings.

Impact of revision: VCU will be able to comply with SCHEV submission deadlines and will be quicker to market with academic program actions and organizational changes requiring SCHEV approval that do not require BOV approval.

<u>Additional steps</u>: The revision of the AHAC Charter and Meeting Planner is part of a comprehensive and streamlined process that includes:

- Implementing SCHEV proposal cohorts with start and end dates tied to SCHEV's published guidelines.
- Restructuring university-level curriculum committees to ensure thorough vetting of certificate and degree program proposals for shared governance.
- Amending University Council bylaws to eliminate review/approval of curriculum/SCHEV proposals, which is duplicative of the work managed under the purview of the faculty by the undergraduate and graduate curriculum committees.

51 must be free from any financial, family or other material personal relationship that, in the opinion of the

52 Board or Academic and Health Affairs Committee members, would impair their independence from

53 management and the University.

55 III. MEETINGS

56 The Academic and Health Affairs Committee will meet at least four times annually. Additional meetings may 57 occur more frequently as circumstances warrant. The Committee chair should communicate with the Provost 58 and Senior Vice President for Academic Affairs and the Senior Vice President for Health Sciences and CEO 59 of the VCU Health System prior to each Committee meeting to finalize the meeting agenda and review the

Nibir K. Dhar, Ph.D., professor CCI Eminent Scholar Electrical and Computer Engineering Director of Virginia Microelectronics Center VCU College of Engineering

Presentation overview

Dr. Dhar will discuss the Convergence Lab Initiative and its strategy for advanced research and development, education, workforce and growth,

funded with \$27M over three years by the Department of Defense. He will cover how the technologies housed under the Initiative (microelectronics, AI/ML and neuromorphic, biomedical, arts, quantum/photonics) will come together with federal and corporate partners to build new capabilities for future investment and growth.

Bio

Dr. Dhar is a fellow of SPIE and OSA (OPTICA) and a senior member of IEEE. Dr. Dhar received a Ph.D. in Electrical & Computer Engineering (ECE) from the University of Maryland at College Park. In 2021, he became a professor at the Electrical and Computer Engineering Department at VCU. Dr. Dhar is currently the director of the Virginia Microelectronics Center at VCU. He served for 33 years in the Department of Defense. He led the EO/IR imaging technology for the US Armed Forces. He joined Night Vision and Electronic Sensors Directorate (NVESD) in 2014 as the Chief Scientist. At NVESD, he was involved with the R&D programs in materials, detectors, FPAs, optics, image processing, and EO/IR systems in the imaging science and technology area. He founded a workforce development effort called Innovative Discovery Science Platform (iDISPLA) that focused on STEM education and the talent pipeline for the Department of Defense. He served as the program manager at DARPA. Before DARPA, he was the branch chief and team lead in EO/IR technology at the Army Research Laboratory.

He received numerous R&D achievement awards, technology transition awards, and industry awards for his technical contributions in the field of Infrared science. He received the DARPA technology transition award (Results Matter) in 2013, the Office of the Secretary of Defense Medal for Exceptional Public Service in 2014, the Henry Levinstein lifetime achievement Award in 2016, and a Technical excellence award in 2018.

He is a member of the Optical Society of America, IEEE, Eta Kappa Nu IEEE honor society, and member of Golden Key honor society. He served as an adjunct professor at George Mason University and the University of Illinois at Chicago and mentored twelve Ph.D. students in various subjects through these activities. He has published numerous technical papers and book chapters.



Kim McKnight, Ph.D. Director, VCU Center for Teacher Leadership Executive director, RTR Teach Residency School of Education





Dr. McKnight will discuss the RTR Teacher Residency, the program she leads, and its significant impact. Over the last 13 years, the program has been

awarded over \$35 million dollars through federal, state, school divisions, and local philanthropic organizations to recruit, train, support, and retain teachers and school leaders in the Commonwealth.

Bio

Dr. Kim McKnight has directed the expansion of VCU's RTR teacher residency program in Chesterfield County Public Schools, Petersburg City Public Schools, and helped create graduate certificate pathways that increase the number of teachers in hard to staff schools. Previously, she served as an education consultant for The Cameron Foundation and project coordinator for the first year-round school in Chesterfield County Public Schools, Bellwood Elementary. From 2014 to 2017, she was a BEST in CLASS coach for teachers in City of Richmond schools. Current research topics include building trust between teachers and their students' families, facilitating strong partnerships between residents and coaches during their residency year, and supporting area school divisions who are partners of RTR. McKnight was born in Richmond and is a former National Board certified elementary school teacher in the Greater Richmond area. F. Gerard Moeller, M.D., professor Department of Psychiatry, School of Medicine Director, Wright Center for Clinical & Translational Research Associate Vice President for Clinical Research Office of the Vice President for Research and Innovation

Presentation overview

Dr. Moeller will discuss the recent funding of the Clinical and Translational Science Award (CTSA) by the NIH for the next 7 years. He will discuss the

national recognition of VCU in clinical research that comes with a CTSA grant, and provide an overview of the objective of that grant to Advance health equity through actively engaging diverse communities, training a diverse research workforce, and supporting translational science. He will give specific examples of high impact clinical research that the CTSA and the Wright Center have supported, including research highlighting the impact of extreme heat on healthcare costs and an innovative partnership with Virginia Opioid Abatement Authority to develop a tool kit for cities and counties to support evidencebased prevention and treatment methods to tackle the opioid overdose epidemic.

Bio

Dr. Moeller is a physician scientist who serves as the Associate Vice President for Clinical Research within the Office of the Vice President for Research and Innovation at Virginia Commonwealth University. He also serves as the Director of the C. Kenneth and Dianne Wright Center for Clinical and Translational Research, which is VCU's clinical and translational science award funded research center. In addition, he is the VCU's Director of the Institute for Drug and Alcohol Studies and Division Chair for Addictions within the Department of Psychiatry. He is board certified in Psychiatry and Addiction Medicine. He is internationally known for his research on the neurobiology of addictions as a tool to for medication develop for stimulant and opioid use disorder. He has been funded by the National Institutes of Health for his research since 1996, and currently is principal investigator on NIH grants from the National Center for Clinical and Translational Science and the National Institute on Drug Abuse.



Amy Salisbury, Ph.D., R.N., professor Director of Research, Institute for Women's Health Associate Dean for Research, Scholarship, & Innovation Steigleder Endowed Chair for Research School of Nursing



Presentation overview

Dr. Salisbury will cover the NIH RECOVER Initiative in her presentation. VCU's School of Nursing is one of nine main pediatric hubs across the U.S., enrolling over 19,000 children, adolescents, and young adults, ages 0-25 into said Initiative. It is patient-centered and community-based and is the largest multi-site study in the U.S. focused on understanding, predicting, and treating postacute sequelae from SARS-COV-2 infection (PASC) in people of all ages. The School is partnering with other VCU community-engaged programs, such as the HRSA-funded, VCU-SON Mobile Health and Wellness Program, to use novel methods to engage participants in their communities and also act as a bridge between research and care coordination.

Bio

Dr. Salisbury received a Ph.D. in Developmental Psychobiology from the University of Connecticut, a M.S. in Nursing from the University of Rhode Island, and is a licensed nurse practitioner in child and family psychiatry. She has expertise in the measurement and assessment of fetal and infant neurobehavior and sleep development. Her work includes longitudinal research examining the impact of prenatal substance use, maternal psychiatric conditions, and their treatments on neurodevelopmental outcomes. This work contributes to the evidence base for informed risk-benefit decisions for pregnant patients and their care providers and the development of novel interventions for improved outcomes for pregnant persons and their children. Dr. Salisbury joined the School of Nursing as the Associate Dean for Research in 2020, following a successful clinical research position at Women & Infants Hospital and the Alpert Medical School at Brown University for nearly 20 years. Since 2020, the research portfolio of the School of Nursing has grown by 354% in federally sponsored research. The School of Nursing has a shared vision of innovative, community-engaged research that is producing high-impact programs, interventions, and equitable health outcomes.





Vanessa B. Sheppard, Ph.D., professor Interim Founding Dean, School of Population Health Theresa A. Thomas Memorial Chair in Cancer Prevention and Control Associate Director, Community Outreach Engagement & Disparities Research Massey Comprehensive Cancer Center

Presentation overview

Dr. Sheppard's presentation will highlight the impact of her research program related to health inequities in Virginia. Examples of non-therapeutic intervention trials and cancer care delivery research will be discussed.

Bio

Dr. Vanessa B. Sheppard is Professor and Interim Founding Dean of the VCU School of Population Health. Prior to this appointment, she served as chair of Health Behavior and Policy in the VCU School of Medicine. Dr. Sheppard is the inaugural associate director of Community Outreach Engagement and Health Disparities Research at VCU Massey Comprehensive Cancer Center. She holds the Theresa B. Thomas Memorial Chair in Cancer Prevention and Control. Prior to joining VCU, Dr. Sheppard was tenured at Georgetown University and Assistant Director for Disparities Research at the Lombardi Comprehensive Cancer Center.

Recognized by the NIH as a health equity expert, her research has been supported by the National Cancer Institute, the National Institute for Nursing Research, the American Cancer Society, Susan G. Komen, Inc., and other entities. In 2023, Dr. Sheppard was named the American Cancer Society's Researcher of the Year. This prestigious award recognized her outstanding contributions to cancer research, advocacy, and policy and her commitment to improving cancer care for patients and families. She is currently PI and MPI on awards focused on enhancing cancer care delivery and access to clinical research for populations typically underrepresented in cancer clinical research. Her novel interventions have been the first to address disparities in uptake and adherence to adjuvant systemic therapy and hereditary cancer care for Black and Latine populations.

As a scientist committed to impacting workforce diversity, she leads and has co-led initiatives funded by the National Science Foundation and the National Cancer Institute. Her administrative contributions include significant increases in institutional research funding, founding the Office of Health Equity and Disparities Research, developing the Massey Office of Community Engagement, and founding VCU's School of Population Health to address gaps in Virginia's public and population health workforce.



Program Announcement

Board of Visitors Meeting September 15, 2023
