Speakers will proceed in the order of registration and should be online at the start of the meeting at 1p.m. to facilitate meeting operations. Speakers will be limited to a maximum of three minutes each.

Preference will be given on a first-come, first-served basis. The first 20 individuals to register will have the opportunity to speak during the public comment period; individuals beyond the first 20 to register may submit written comments (see below).

Individuals unable to virtually attend the public comment period or to provide comment during the allotted onehour period may provide written comment via an open comment portal to ensure an adequate opportunity for informed public comment on the proposed agenda items. All comments submitted to the portal must be by 4:30 p.m., Friday, July 24.

In accordance with board procedures, there will be no opportunity for public comment during the meeting other than during the public comment period.
