CALL TO ORDER

Hon. Todd Haymore, Vice Chair of the Intercollegiate Athletics Committee, called the meeting to order at 2:02 p.m.

ACTION ITEMS

Hon. Haymore mentioned the December 8, 2022 committee minutes were posted online and in BoardEffect. On a motion duly made and seconded the December 8, 2022 Intercollegiate Athletics Committee minutes were approved unanimously. Virginia Commonwealth University Board of Visitors Intercollegiate Athletics Committee March 23, 2023 Minutes

VICE PRESIDENT AND DIRECTOR OF ATHLETICS REPORT

Mr. Ed McLaughlin, Vice President and Director of Athletics provided an athletics update. He recognized the VCU Men's Basketball Team and Women's Track and Field for their very successful seasons. He shared updated academic success for Fall 2022 Women's sports programs including Track & Field / Cross Country Women's cumulative GPA was 3.21, Basketball 3.11, Field Hockey 3.51, Volleyball 3.43, Soccer 3.63, and Lacrosse 3.56. Men's sports programs academic successes included Track & Field / Cross Country cumulative GPA 3.07, Baseball 3.19, Basketball 2.72, and soccer 3.16. As a department there have been 16 consecutive semesters at 3.0

Mr. McLaughlin also shared an update on the Athletics Village and the master planning process and shared a rendering. The committee emphasized the importance of having practice fields/

Mr. McLaughlin shared more information since the December meeting on changes to the national landscape of collegiate athletics, including the presidential transition and transformation committee. He reported that VCU is already doing a lot of what the transformation committee is discussing.

He also provided updated numbers on name, image and likeness numbers. This is a good thing, but the collectives are tricky. Ms. Karol Kain Gray, Senior Vice President and CFO, recommended the members read an article that was in the New York Times. Mr. McLaughlin said he believes most likely there will be no federal legislation until 2025.

He also provided an update on the DEI Strategic Op Plan. 8 goals have been achieved, 13 in progress, and 2 not started. Key future objectives include identifying opportunities to strengthen engagement with diverse groups of qualified minority applicants and developing strategic DEI priorities as part of the 2023-2028 VCU Athletics strategic planning process in alignment with university-level strategic DEI goals and priorities.

Lastly, he Mr. McLaughlin addressed some of the challenges. The committee and he agreed that there are some amazing stories at VCU around athletes and they need to be told – the VCU story needs to be told.

CLOSED SESSION

Hon. Haymore moved that the Intercollegiate Athletics Committee of the Board of Visitors of Virginia Commonwealth University convene a closed session under Section 2.2-3711(A) (3) of the Virginia Freedom of Information Act for the discussion or consideration of the acquisition of real property for a public purpose, or of the disposition of publicly held real property, where discussion in an open meeting would adversely affect the bargaining position or negotiating strategy of the public body, specifically related to real property to be used in for Intercollegiate Athletics. The motion was seconded and was approved unanimously.
