CALL TO ORDER

President Rao welcomed members of the VCU Board of Visitors and VCU Health System Board of Directors to this meeting, as well as staff, the media and public. CLOSED SESSION

President Michael Rao moved that the VCU Board of Visitors and VCUHS Board of Directors convene a closed session under Section 2.2-3711(A)(1) of the Virginia Freedom of Information Act for the discussion of personnel matters related to an Executive Position; under Section 2.2-3711 (A)(7) and (8), for consultation and discussion of matters requiring the provision of legal advice by counsel, relating to an update on potential and current litigation in state and federal courts and other legal matters relating to pending investigations; under Section 2.2-3711(A)(23) to discuss the acquisition or disposition by the Authority and /or the University of real property and operational strategies where disclosure of such strategies would adversely affect the competitive position of the Authority and /or the University and; and under Section 2.2-3711(A)(29) for the discussion of the award of a public contract involving the expenditure of public funds, including interviews of bidders or offerors, and discussion of the terms or scope of such contract, where discussion in an open session would adversely affect the bargaining position or negotiating strategy of the public body.

Following the closed session, the public was invited to return to the meeting. President Rao called the meeting to order. On a motion duly made and seconded the following resolution of certification was approved by a roll call vote:
