CALL TO ORDER

Rev. Tyrone Nelson, Chair of the Intercollegiate Athletics Committee, called the meeting to order at 10:49 a.m.

INTERCOLLEGIATE ATHLETICS UPDATE

Mr. Ed McLaughlin, Vice President and Director of Athletics introduced Head Men's Basketball Coach Ryan Odom. Coad Odom talked about his first season at VCU and highlighted areas of strengths and improvements for the team. He shared updates on player commitments and the very competitive recruiting visits that have taken place over the last few weeks. He emphasized that the upcoming year is big and that VCU has a positive national reputation. He spoke about Name, Image, Likeness (NIL) as well as the transfer portal. He thanked the board, president, and Mr. McLaughlin for their support. The board applauded Coach Odom for a great season and representing VCU.

Mr. McLaughlin then presented information about student athletes' academic success and spotlighted VCU's spring 2024 Atlantic 10 competitive successes. He recognized the competitive successes including three spring A-10 champions: Men's Tennis, Men's Golf, and Women's Track.

He continued by discussing the continuing NCAA challenges that include the transfer portal, NIL, NCAA deregulation, and U.S. Supreme Court cases. These challenges are things VCU is working on and watching every day.

CLOSED SESSION

Rev. Nelson moved that the Intercollegiate Athletics Committee of the Board of Visitors of Virginia Commonwealth University convene a closed session under Section 2.2-3711(A)(3) of the Virginia Freedom of Information Act for the discussion or consideration of the acquisition of real property for a public purpose, or of the disposition of publicly held real property, where discussion in an open meeting would adversely affect the bargaining position or negotiating strategy of the public body, specifically related to real property to be used in for Intercollegiate Athletics. The motion was seconded and was approved unanimously.

Following the closed session, the public was invited to return to the meeting. Rev. Nelson called the meeting to order. After motion duly made and seconded the motion was unanimously approved.
